BIOSECURITY GUIDELINES WHEN ATTENDING BIRD SHOWS

Before the Show

You must be a registered bird keeper to exhibit at this show.

Before setting off check that your birds are in good health and fit to travel to the show.

Ensure that your show cages, boxes and other equipment are free from any bird contaminants, or you will not be admitted to the show.

During the Show

When entering the show hall unload your birds at a location where they can be inspected prior to being benched with other birds.

If your birds are found to be unwell or their cages unclean, you will be asked to remove them from the show, and they may be subject to a veterinary examination and referral to APHA.

After the Show

Check that your birds are still in good health and fit to travel before leaving the show.

Check that your travel boxes/bags are free of any contaminants before leaving.

On returning home isolate your birds from other birds at home and monitor their health for a week before re-introducing them.

Clean and disinfect your show cages, boxes and equipment as soon as possible after arrival home and certainly before they are used again.
